Twelve Initiatives have been approved for the November 4th California ballot; seven are pending approval and eight are still circulating (you may be happy to know that so far eight have failed to qualify). Take this seminar to be prepared!

The preeminent political columnist David Broder entitled his book about the initiative in California and the US *Democracy Derailed, Initiative Campaigns and the Power of Money*. Whether the initiative has “derailed” democracy is the theme for this course. We will examine the background of the initiative and the other Progressive-era reforms that have shaped contemporary California government and look at the process for approving initiatives at the state and local levels. Among the issues we will consider are:

Whether the initiative is too inflexible—too difficult for proponents or the legislature to correct errors or amend. Is there a fair way to institute these changes?

Should the legislature play a role in the initiative process? If so, what role?

Initiatives are so long and complex that many voters do not understand them—can we get them better information?

Initiatives are too easy to qualify with paid circulators and too difficult for those who lack the \$1-3 million necessary—can the process be more fair?

Money plays an important role in the initiative process. How could this be changed?

What is the role of the courts in the process?

His experience includes two years working in the U.S. Department of Health and Human Services on health policy issues in the 1990s, four National Science Foundation grants, and chairing both his department and the campus Academic Senate for several years. He has taught at Cal State LA, UCSB, the University of Rochester and two institutions the Universities of Canterbury and Waikato in New Zealand.
